

Mandatory Event & Lure Course Waiver Form

I wish to attend **Dog Fest Muskoka event and/or DogLoversDays lure course with my dog**. I understand and agree that this signed waiver is **mandatory** to gain admittance to the event, and/or participate in the LURE course and all other activities at Dog Fest Muskoka with my dog. In acknowledging so, I hereby agree to the following terms and waiver:

Rules:

- Dogs that have been exposed or affected by the Canine influenza virus are not permitted to attend!
- All dogs must be either on a leash not exceeding 6 feet in length, or in a suitable harness/containment
- Owner must clean up after his/her dog
- Dog owners must report any incidents to event staff
- Dog owners must adhere to Dog Fest Muskoka & DogLoversDays Lure course rules, and obey, if asked to leave.
- Your dog must be legal to own in the City/Town, and conform to all city by-laws.
- You must obey posted signs regarding access to designated areas.

Eligibility Requirements:

- Fill out and sign this registration and waiver form below
- Confirm that your dog is up to date on both rabies and distemper vaccinations if required.

Certification:

- I hereby certify to the following facts and agree to the following terms:
- I take full responsibility for my dog attending Dog Fest Muskoka and will be in control of my dog at all times
- All the information contained in this registration and waiver is true and accurate
- My dog is not aggressive, not in heat, has not been exposed or affected by the Canine Flu Virus, and has not had incidents of biting or shown aggression in the past.
- My dog has never caused bodily or property damage

Indemnification: I am aware that during the course of my visit to Dog Fest Muskoka, and/or DogLoversDays lure course certain inherent risks are involved because I am attending with my dog, along with other attendees' dog. In consideration for being allowed to attend Dog Fest Muskoka with my dog, I acknowledge and voluntarily accept and assume full responsibility for any risks to me and my dog, and further agree I waive and release any and all claims that I may have against Dog Fest Muskoka & DogLoversDays, 2501012 Ontario Inc., it's organizers, directors, officials, sponsors, event facility, any and all employees and volunteers of the aforementioned organizations and agree not to sue for losses, damages, expenses or fees which arise out of or result from, or are related to in any manner my attendance to Dog Fest Muskoka.
